Staff Summary: Since FY 2015/16, the Redevelopment Authority Citizens Committee allocates 40% of its Special Event Funding to the Cultural Commission for recommendation of grant allocation to Arts & Culture events in the Redevelopment Districts. Over the next 5 years this amount from the Redevelopment Authority Citizens Committee decreases incrementally, effecting Arts & Culture grant applicants.
