## **AMENDMENT TO SPONSORSHIP AGREEMENT #CTA-SA-20-01**

BIKE MONKEY, INC., a California corporation (the "Event Owner") and the CARSON CITY CULTURE & TOURISM AUTHORITY (the "Sponsor") hereby consent to change the dates for the Peter Stetina's Carson City Paydirt Prospect Ride (the "Event") as follows:

Whereas, the current Sponsorship Agreement #CTA-SA-20-01 (the "Agreement") provides that the sponsorship shall commence on the 1<sup>st</sup> day of July, 2019, and unless terminated pursuant to Section 5, shall automatically terminate on June 30, 2022 (the "Term"). The Agreement additionally provides that the Event shall be held in April/May of 2020, 2021, and 2022. Further, the Agreement provides that the Sponsor agrees to provide \$69,000 in sponsorship fees paid the following installments:

- o 2020 Event
  - \$23,000 by August 1, 2019
- o 2021 Event
  - **\$23,000** by August 1, 2020
- o 2022 Event
  - \$23,000 by August 1, 2021

Whereas, the Agreement provides that it may only be amended by mutual written consent of the parties.

Therefore, the Event Owner and the Sponsor agree that the date for the 2020 Event will be changed to the month of September. The Event held in 2021 and 2022 shall be held in either April/May or September. The Event shall automatically terminate on December 31, 2022, unless terminated pursuant to Section 5 of the Agreement.

Further, the Event Owner and the Sponsor agree that the Sponsor shall provide \$69,000 in sponsorship fees paid in installments as follows over a 3 year term:

- o 2020 Event
  - **\$23,000 by July 31, 2020**
- o 2021 Event
  - **\$23,000 by July 31, 2021**
- o 2022 Event
  - **\$23,000 by July 31, 2022**

Except as set forth in this Amendment, the Agreement is unaffected and shall continue in full force and effect in accordance with its terms.
