*Staff Summary: The proposed Agreement between Carson City and CTA obligates 5 and 13/16% of a 7% transient lodging tax imposed by Section 4.08.080(1) of the CCMC and collected by STA over the next 21 years and pledges these revenues toward repayment of the proposed \$5,000,000 general obligation park bonds of the City. The City anticipates issuing the general obligation park bonds in order to acquire, reconstruct, construct, improve, extend and better recreational facilities including but not limited to, improvements at the JohnD Winters Centennial Park Complex. The proposed resolution authorizes and ratifies the execution and delivery of the Agreement.*
