Dear David Peterson- Thank you for your application for Travel Nevada's 3D Project Funding. We are pleased to inform you that the Cultural Corridor's application has been approved in the amount of \$631,350. The 3D Project Working Group was impressed by your application, and wanted to provide you with the following feedback: This project aligns with the 10-year Destination Plan, is well considered, well-articulated, and is likely to provide a strong base upon which to build a strong creative economy. This project provides quality of life enhancements for residents of the corridor while taking meaningful steps to build a reputation as an arts and culture tourism destination. The Working Group recommends that the Project Leads consider some adjustments to the budget. These include changing the "Murals" and "Sculpture" categories to a more general "Public Art" category to allow for more flexibility and considering an increase to the contract amount of the executive director for the proposed non-profit to ensure that the organization is able to attract the best candidates. It was also noted that the Cultural Corridor should look for ways to partner with the region's existing outdoor recreation economy. The State of Nevada hereby promises, in consideration of the promises made by the Grantee herein, to obligate to the Grantee the amount of money set forth above and to tender to the Grantee that portion of the obligation which is necessary to pay the State of Nevada's share of the costs of the above project, based on the above percentage of assistance. The Grantee promises, in consideration of the promises made by the State of Nevada herein, to execute the project described above in accordance with the terms of this agreement.

The Commission on Tourism's grant guidelines are in effect as of the date of this agreement, as hereafter amended upon notice of said amendment, and the application for grant funds submitted by the Grantee and approved by the Commission on Tourism.

If special conditions have been placed upon this grant, they are enumerated below.

THE FULL GRANT AWARD MUST BE EXPENDED AND REPORTING COMPLETED BY THE AWARDEE NO LATER THAN JANUARY 30, 2026.

Your grant award includes the following conditions:

Grant funds will be used to pay only those expenses included in the approved program budget and in support of the destination development project as approved by the Nevada Commission on Tourism. Any changes to the approved budget must be approved through an amendment with Travel Nevada. All funds must be expended in accordance with the Travel Nevada 3D Project FY25 Funding Guidelines.

Travel Nevada 3D Project Funding Grant Agreement

I the undersigned hereby agree that:

- a.This grant is awarded for the purpose of promoting travel and tourism to and within the state of Nevada as set forth in the application for grant funds approved by the Nevada Commission on Tourism and must be used for no other purpose.
- b.All grant funds must be expended within two (2) years from the date of award.
- c. Grants may be audited at any time by the Nevada Division of Tourism, Legislative Auditor, Attorney General, or its representatives. All grants will be audited upon completion.
- d.Grant reports and evaluations must be completed to the satisfaction of the Division of Tourism prior to consideration of further applications from the Grantee.
- e.Grantee must notify the Division of Tourism, in writing, of the completion of the grant project, including completion of the required evaluation of the project.
- f. This grant award is made subject to the provisions of the approved application, grant guidelines, and any applicable state regulation and statute.
- g.Awardees will initially be disbursed one half of their award amount. Evidence must be presented that the obligation or expenditure has been made for the purposes presented in the application for grant funds and approved by the Nevada Commission on Tourism before additional grant funds may be requested and disbursed.
